- 9. Julia Brandreth's motion re donation to GLATUC. Following discussion at July's meeting on Julia Brandreth's motion to make a donation to GLATUC www.glatuc.org.uk. Seamus MacBride (Branch Chair) and I met with the GLATUC Secretary and Treasurer from that meeting we wrote a paper for the Branch Committee with some ideas on how we might support GLATUC. Following the last Branch Committee meeting where as agreed Julia and Laurie were invited it was agreed that the BC would recommend to the Branch meeting
